የኢትዮጵያ ካፒታል ገበያ ባለሥልጣን ባፀደቀው የአቢሲንያ ባንክ አ.ማ የደንበኛ ሳቢ መግለጫ እና በተሠጠው ፈቃድ መሠረት 3,125,000 (ሶስት ሚሊዮን አንድ መቶ ሃያ አምስት ሺህ) መደበኛ አክሲዮኖችን በአንድ የአክሲዮን ዋጋ ብር አንድ ሺህ ስድስት መቶ (1,600) ሽያጭ ያከናውናል። ሆኖም ለአክሲዮን ሽያጭ የተፈቀደውን ጊዜ ማራዘም አስፈላጊ ሆኖ ስለተገኘ ቀደም ሲል እስከ የካቲት 24 ቀን 2018 ዓ.ም ድረስ የነበረው የአክሲዮን መግዣ የጊዜ ገደብ እስከ መጋቢት 9 ቀን 2018 ዓ.ም የተራዘመ መሆኑን እያስታወቅን በተጠቀሰው ጊዜ ውስጥ በኢትዮጵያ ካፒታል ገበያ ባለስልጣን እውቅና ከተሰጣቸው የሰነድ ሙዓለ ንዋይ አገበያዮች (ደላሎች) በኩል የግብይት ሂሳብ (Trading Account) በመክፈት የአክሲዮን ግዢውን ማከናወን የምትችሉ መሆኑን በአክብሮት እንገልጻለን።

In accordance with the approval granted by the Ethiopian Capital Market Authority (ECMA) on the Prospectus of Bank of Abyssinia S.C., and based on the authorization provided, the Bank is offering Three Million One Hundred Twenty-Five Thousand (3,125,000) ordinary shares for sale at a price of One Thousand Six Hundred Birr (Birr 1,600) per share.

However, as it has become necessary to extend the period permitted for the share sale, the previously announced share subscription deadline, which was set to expire on March 3, 2026, has now been extended until March 18, 2026.

Accordingly, during this extended period, investors may purchase shares by opening a trading account through investment intermediaries (licensed brokers) recognized by the Ethiopian Capital Market Authority, and completing the share purchase process through these intermediaries.
